2020 Distribution Estimates*

The following distribution estimates are based on income and capital gains earned by Empire Life Mutual Funds (the "Funds") in the taxation year to October 30, 2020. Actual distributions will be based on income and capital gains earned by the Funds to December 14, 2020. The taxation year-end is December 15, 2020 for all Funds.

All Series T6 and T8 units of the Funds, the Empire Life Monthly Income Mutual Fund and Empire Life Emblem Diversified Income Portfolio will receive their regular monthly distributions on or about December 31, 2020. Any additional distributions consisting of income and capital gains on these series must be reinvested in additional units of the Fund.

The year-end distributions are also scheduled to occur on or about December 31, 2020.
